#### LEAPING INTO K

"When this idea got hatched... it just made sense to invest and give it a chance to be piloted," said Dr. Valerie Hepburn speaking to the Foundation's long-standing focus on early childhood literacy. A grant of over \$40,000 was given to fund the launch of Glynn County's Jumpstart Summer Pre-Kindergarten program. Due to the partnership between the Foundation and Glynn County School System, four and five-year olds who had not attended pre-school classes previously spent the month of July preparing for kindergarten. From 8 a.m. to 1 p.m., students learned to identify numbers, shapes and colors, while developing social skills and beginning to learn to read. The evidence-based design and a curriculum modeled after nationally recognized programs aims to give at-risk students the opportunity to start kindergarten ahead or at the same level as their peers.

Glynn County preschool principal Stephanie Thompson and Executive Director of Early Academics Sung Hui Lewis, along with three certified teachers, three paraprofessionals and a lead teacher experienced in such programs, taught and led the three-week pilot program at Goodyear Elementary School. Collectively, the students read more than 300 hours in that month.

The Foundation was pleased to support this critical program which was designed to help ease the "transition to school" for these potentially vulnerable students and help assure their future academic success.

#### THE RAYMOND AND ELIZABETH BAUMEL AND ABERNATHY FUND FOR ANIMAL WELFARE



This endowed fund annually provides for the care, feeding, medical attention and sheltering of stray and unwanted dogs due to the forethought of Raymond and Elizabeth Baumel. In establishing this fund, the Baumels have created a lasting legacy as well as a permanent income stream to support their passion.

In 2016 this fund granted over \$2,600 each to Glynn County Animal Control and the Humane Society of South Coastal Georgia.

#### MORE TREES PLEASE

Along with its marshes and beaches, nothing captures the essence of Coastal



Georgia more than its tree canopy. As one of the most predominant natural features of the Golden Isles landscape and a key characteristic for both tourism and nativism of the area, many of our citizens erroneously believe that our magnificent tree canopy has been deliberately protected and regulated. While federal and state law and regulations protect beaches and marshes, our tree canopy is vulnerable and can only be protected and preserved by local action.

Established in 2015 to provide for the preservation and enhancement of the tree canopy in Glynn County through education, advocacy and the planting, maintenance and replacement of trees, the Golden Isles Fund for Trees (GIFT) has already made a significant impact in the community it serves. Since planting its first tree, a live oak, on February 17th, 2016, GIFT has engaged in numerous education, public policy and preservation activities and has recently started work to obtain "Tree City, USA" status from the National Arbor Day Foundation for Jekyll Island, St. Simons and Brunswick.

## The Decennial Campaign was launched in 2015 with the goal of building an Operating Endowment necessary to sustain the Foundation's work for decades to come.

In the first year of this initiative, 35 families, foundations and organizations donated or pledged to this important effort. Their gifts, combined with the support of the original Founders, helped the Decennial Campaign reach two-thirds of its goal.

By the end of 2016, thanks to 62 donors, the campaign was over 90% of the way toward "endowing" a \$3.5M fund to support the Foundation's operations and ensure permanent, impactful philanthropy in our region. We are grateful for those who have made investments in this campaign and welcome those who would join with us for a successful conclusion to ensure community philanthropy exists in Coastal Georgia "for good, forever."

## COMPETITIVE GRANTS AWARDED: MAKING A REAL IMPACT

Through its competitive grant cycle, the Foundation awarded grants totaling \$62,000 to 16 communitybased organizations serving Glynn, Camden and McIntosh counties.

In addition to donor-advised and field of interest grantmaking throughout the year, the Community Foundation annually conducts a competitive grants cycle which targets specific areas of need and opportunity across the three-county region. The 2016 cycle focused on programs serving at-risk youth and their families.

Strengthening local, not-forprofit service organizations is part of the mission of the Community Foundation, and the grant process is designed to build both financial and organizational capacity. Four of this year's 16 grant recipients are firsttime applicants.

#### THE ART OF GIVING

**Morningstar Children and Family Services, Inc., Glynn County\*** A \$5,000 grant supported the Art Therapy program for youth in foster care. Most youth at Morningstar have suffered from abuse and neglect. This program provides to those youth a safe method for expressing their emotions while increasing their selfawareness and self-esteem.

#### AN IMPACT IN MCINTOSH McIntosh County Extension/4-H, Darien The Foundation granted

Foundation granted \$3,400 to the 4-H Sprouts, a horticulture program for ages 9-11. Activities of the program promote



positive experiences for youth while they learn about growing plants, gardening practices, healthy lifestyles, and the environment.



#### Camden County Health Department, St. Marys

The health department has provided basic vision screening for children ages three through five as part of school readiness requirements. With the help of a \$5,000 grant, the department was able to purchase a Spot Vision Screener. The small machine uses a noninvasive method to quickly and accurately detect vision problems in children. This equipment will make possible the screening of children as young as six months to aid in the early detection of vision disorders. Early detection of vision problems increases the likelihood of effective treatment. Less than 22% of preschool children currently receive some type of vision screening.

#### I AM A G.I.F.T.

#### Girl Scouts of Historic Georgia, Inc., Serving Glynn and McIntosh

**County**\* A grant of \$4,946 was awarded to support the delivery of "I am a GIFT (Gorgeous, Intelligent, Fabulous, and Talented) You Will Not Abuse Me", a dating/domestic violence prevention program for girls and their mothers/guardians.

#### Camden County CASA (Court Appointed Special Advocates) Program,

**Kingsland** For those staff and volunteers advocating for safe, permanent homes for abused and neglected children, a \$1,362 grant supported technology upgrades of computers and software and increased staff efficiency.

#### CASA (Court Appointed Special Advocates) Glynn, Inc., Brunswick

A grant of \$2,900 supported training of staff and advocates in a new Educational Advocacy program to improve the educational outcomes for children in the Foster Care system.

**Children In Action Sports Club (CIA), Brunswick** CIA was award a \$4,500 grant to support the Summer Outreach program and Barnabas Club. CIA utilizes sports and activities as a vehicle to help at-risk children and youth build confidence, develop character, strive for excellence, and engage in teamwork while incorporating Christian values.

**Communities In Schools of Glynn County, Brunswick** A grant of \$5,000 supported 40 qualified junior and senior high school students in their professional development with tools that included the Birkman Personality Assessment, interview coaching, first impressions, self leadership, communication and customer service training.

**The Gathering Place, Brunswick** A grant of \$4,000 was awarded to support the annual summer college tour, providing rising high school seniors the opportunity to visit a wide range of academic and technical colleges across Georgia. The program also assists students with the preparation of college applications and provides ongoing support during their college years.

**Glynn County Board of Commissioners/Juvenile Court, Brunswick\*** Kidsnet Glynn, a program to provide behavior management, family advocacy and parent education to youth and families involved with the Juvenile Court, was able to serve more participants by virtue of a \$5,000 grant. The goal is to reduce commitments and recidivism.

#### International Seafarers Center/Port as a Classroom, Brunswick\*

\$1,500 granted to the International Seafarers Center provided a video camera and voice recorders for Port as a Classroom, which is a specialized curriculum for middle and high school students. With this program, students are able to dive deeper into learning about maritime shipping, geography, the sciences, and the global trade system.

**Marshes of Glynn Libraries, Brunswick** The Foundation provided support in the amount of \$4,992 to continue the Targeted Early Literacy Parental Involvement Initiative across Glynn County. Building from the Community Foundation's successful Baby Steps initiative, Marshes of Glynn Libraries educates parents and caregivers about the importance of developing early literacy skills for their children.

**Safe Harbor Children's Center, Inc., Brunswick** Much-needed case management software that increases efficiency and performance monitoring in the center was purchased with the help of a \$5,000 grant from the Foundation. This software helps to free staff for more individualized time with the children.

**STAR Foundation, Brunswick** A Community Outreach Coordinator position was supported by the grant awarded to STAR in the amount of \$5,000. The individual works with local non profits, schools and agencies to increase student participation in the program, which teaches computer and life skills for a successful transition into the workforce.

#### YMCA of Coastal Georgia, Inc., Serving Glynn and McIntosh

**Counties** \$2,000 was awarded to purchase books for the Y Summer Camp Readers of the McIntosh County and Golden Isles YMCAs. The program is designed to mitigate learning losses during school breaks by encouraging children to read throughout the summer.

## THE GLYNN ACADEMY CLASS OF 1969 SCHOLARSHIP FUND

Glynn Academy enjoys a remarkable history. Founded in 1788, it is the second oldest high school in Georgia, and the fifth oldest in the United States. The last "all city" class to graduate from Glynn Academy did so in 1969. To commemorate this remarkable history and meaningful milestone, members of that class have worked together to establish and fund the Glynn Academy Class of 1969 Scholarship. Their collective generosity will provide a scholarship each year to an outstanding Glynn Academy senior to attend a Georgia college or university. Originally established in 2009 with a different community foundation, the Fund Committee decided it made more sense to "invest their assets locally" and moved them to the Coastal Georgia Foundation in 2016.

## THE HALSEY FAMILY SCHOLARSHIP FUND

### Funding the Future's Talent

**The Halsey Family Scholarship Fund** awarded two very worthy students \$3,000 for up to two academic years to help them complete their undergraduate degrees; one in the biological or physical sciences, and one in music. The fund supports graduating seniors from Camden County High School who attend a U.S. accredited college or university. This year, Noah J. Keeth was awarded the Halsey Family Science Scholarship, and Patriana Griffiths was awarded the Halsey Family Music Scholarship.



### ASSISTING CORPORATE PHILANTHROPY

**Rich's Consumer Brands Charitable Fund,** a new philanthropic arm of Rich Products Corporation's Consumer Brands Division on St. Simons Island, awarded its first two grants in 2016. Their goal is to help support charitable organizations serving Glynn County with a focus on children and healthy activities.

Children In Action Sports Club, a Brunswick based ministry serving children ages 7-12, was awarded a \$25,000 grant that helped fund the nonprofit organization's afterschool program and summer sports camps for children in the Glynn County area.

The Fund also awarded \$25,000 to support the construction of the new Safe Harbor Children's Center in Brunswick. Safe Harbor is the region's safe haven for abused and neglected children. The boys locker room and entrance area of the new facility will carry the name of the Rich's Consumer Brands Charitable Fund.



# CCGF: FOCUSING REGIONAL PHILANTHROPY

#### PROFESSIONAL ADVISORS AND ESTATE PLANNING COUNCIL

A recent development of the Foundation, this initiative brings colleagues together to hear speakers and exchange ideas and innovations in the legal, accounting, investment, financial services and estate planning fields. It provides a forum for learning and the exchange of ideas about the dynamic field of philanthropic giving.

In June, Jeff Bush, noted speaker and tax policy expert with the Washington Update, returned by popular demand for a second time. This year, he focused on how potential outcomes of the 2016 presidential election would impact business, tax and social policy as well as the general US economy. Once again, Mr. Bush received rave reviews, demonstrating the importance of the Foundation's effort to add value to the professional advisors with whom we partner.

In October of 2016, nationally renowned tax and estate planning attorney Ron Aucutt presented to the group on the topic of Current and Looming Issues in Federal Tax Policy. A partner of McGuire Woods, Ron's extensive experience in resolving tax issues through rulings in the Internal Revenue Service's National Office and in administrative appeals throughout the country, allowed for great insights to be shared with the group.

#### COASTAL GEORGIA PARTNERS IN PHILANTHROPY

This donors' affinity group, supported by the Communities of Coastal Georgia Foundation and Stewards of the Georgia Coast, jointly hosted a Conservation Donors Roundtable in March. The event, held at Musgrove Plantation on St. Simons Island, attracted a capacity crowd of interested corporate and private philanthropists.

The program focused on the large-scale, highly collaborative effort to conserve shorebirds, one of the most rapidly declining groups of birds in the world. Some discussion highlights included descriptions of

the remarkable migration routes of many species of shorebirds, with some making annual migrations from the Arctic to South America and back again. Because of these and other factors, Georgia's coast features prominently in National Fish and Wildlife Fund's (NFWF) conservation plans due to the critical role this region plays by providing important habitat and food resources during migration and the nesting season.

Following the event, many participants asked, "how can we help?" In an effort to maximize the impact of a NFWF's recent commitment to fund the regular monitoring of shorebird habitat and populations of Cumberland Island, the Coastal Georgia Foundation coordinated an effort to raise the funds to purchase the required equipment including a light utility vehicle and over a dozen long-range remote IR cameras which are now "in the field."

#### **GRANT SEEKERS GAIN INSIGHTS FOR SUCCESS**

Hosted by the Georgia Center for Nonprofits, two events in November were targeted at preparing nonprofits for grant seeking efforts. To encompass the three counties served, the events were held at the Golden Isles Career Academy and the Old Courthouse in Woodbine. Presenters included Dr. Valerie A. Hepburn with the Community Foundation and Mr. Jeff



Barker with St. Marys United Methodist Church Foundation. Virginia Brown with United Way of Coastal Georgia joined the session at the Brunswick location. Elizabeth Runkle with the Georgia Center for Nonprofits finished the event by speaking on "Understanding Impact and Outcomes."
